Local Level, Suppression and Non-Suppression Programs:

#### All County 1st Responders;

The information on program offerings at the Indiana County Public Safety Academy are intended for you to gain experience and knowledge in basic response techniques and skills. These program offerings are developed and delivered in line with the State Fire Academy "Local Level" course offerings. If there is a program that you would like to have offered, from the State Local Level course listing, please feel free to contact us and we will make every effort to provide that program.

It is anticipated that in 2024, the Local Level Course curriculum's for various State Fire Academy and PA. Dept. of Health programs will be updated. These updates will include the use of a nationally published curriculum and textbooks for students. Standardizing the state training and professional testing should provide students with a seamless transition to seek Professional Certification in many areas.

Also new this year, is the inclusion of 17 year olds in the Interior Fire Fighter and Fire Fighter I Certification Testing. Each of these were added to permit for individuals to get a jump start on their fire service career. Permission slips must be provided for participation and can be obtained from the Academy on request.

Processing student registration is being handled via email. A PDF fillable and printable application is available on our website. Legibility of your personal email is extremely important as all communications regarding courses will be sent directly to the registered student. Also, course completion certificates will be sent via email. Students can keep a digital copy and forward copies to file with their department. State law prohibits us from sending certificates to anyone other than the student who obtained it.

As mentioned above, textbooks will become standardized in future course offerings. Individuals will be required to have a textbook for the classes. Similar to the current Essentials Modules, new programs will be modular and the same textbook can be used for each module. The Academy maintains an account with Lancaster County Fireman's Assoc. for procurement of books, we can purchase in bulk and provide the books for you, or your agency can purchase them direct.

#### LOCAL LEVEL PROGRAM REGISTRATION INFORMATION

The following policies apply to all programs offered by the Academy:

- 1. Students must meet the age requirement established by the State Fire Academy by the starting date of the program. Proof of age can be required and should be available upon request.
- 2. Students with facial hair will not be permitted to participate in programs requiring the use of breathing apparatus per PSFA standards.
- 3. Students will be required to provide their own classroom materials, personal protection equipment, including breathing apparatus, work clothes and safety equipment as required for the program.
- 4. **Students are required to provide proof that the prerequisite training has been completed.** A copy of the pre-requisite certificate must be included with the submission of the course registration form to be accepted into the program.
- 5. Students will be notified by e-mail of specific course information upon registration. A minimum number of students shall be required for any program. Programs will be cancelled, also by email notification, if the minimum number of students for the class to run safely is not met.
- 6. Site fees must be paid in advance to guarantee placement in the program and to take advantage of the discount price for the class. Site fees not paid by the first night of the class, will be invoiced at regular price listed for the class. Site fees not paid by the completion of the course will delay receipt of certification by the student and will be subject to a monthly interest charge.
- 7. Indiana County residents affiliated with municipal or county governments can take advantage of the LEPC HAZMAT Grant programs. Student registration fees are paid by the grant. If you register and fail to show for the class or fail to withdraw from the class, you will be responsible to pay the full amount for the course registration.
- 8. Site fees will be refunded if a program is canceled. If you are unable to attend a course after registration, your cancellation must be received prior to the first program date to guarantee a refund or to guarantee that you are not billed as a student of the class.
- 9. Certification documents will be provided to each student successfully completing a program. Time attendance records will be provided upon request.
- 10. Registration deadlines for all programs are <u>TWO WEEKS</u> prior to the listed starting date unless otherwise indicated on the course outline.
- 11. All students will be required to complete a release from injury form prior to beginning any program at the Indiana County Public Safety Training Academy.
- 12. All fees not paid in 30 days will receive an additional charge of 1½% per month overdue penalty fee.
